



CCLD Component I Orientation

The first step in applying for a license application is to complete an orientation, which is referred to as the *Component I Orientation*.

Orientations can be completed online for ARF's and RCFE's, but are only available virtually or in person for SFH's. The orientation is slightly different for each category of facility and the facility type (ARF, RCFE, SFH) will be printed on the certificate, so be sure you are completing the correct one for the type of facility you will open. At the end of the orientation you will receive a certificate of completion.

If you are applying for an ARF or RCFE license as a multi-person Limited Liability Company (LLC) or Corporation, only the person designated to represent the LLC or Corporation must complete the *Component I Orientation*.
