



Personalized Consultations Related To Licensure Or Vendorization

Consultations are available in-person or by phone.

Many people are left with more questions than answers following their Community Care Licensing (CCLD) Component I or Regional Center (RC) orientation. These meetings are designed for a broad audience with an emphasis on the application materials and regulatory requirements and may not adequately address your individual situation or concerns. The following is a sample list of topics that can be discussed during your *Personalized Consultation*:

- What type or level of facility is best for you?
- What steps are needed to obtain a license or vendorization and in what order should you complete them?
- How much money do you need?
- Should apply for a license as a sole proprietor, corporation, LLC, or partnership?
- What classes, work experience, and other requirements do you need?
- Are there any potential problems with your proposed facility, or will you need to make any modifications?

A *Personalized Consultation* may be needed to answer your questions.

Personalized Consultations will last up to 2-hours and can be held at the proposed facility, over the phone, or at any agreed upon location. All of the following, and more, can occur during our meeting:

- An inspection of the proposed facility to identify any potential problems.
- Assistance in deciding your capacity.
- Answers to your specific questions about the licensing and vendorization process.

Personalized Consultations are ideal for people who have questions or concerns, but are not required if you are ready to begin your license application or Regional Center Program Design. A down payment of \$350 will be processed to start your paperwork without a *Personalized Consultation*.

Choice 1

Personalized Consultations can be held in-person within 30 miles of our address for 2-hours. Your payment is due at the end of the consultation. We do not travel more than 30 miles from our office address. If you are located more than 30 miles from our office, refer to the list of suggested meeting locations on the [Contact](#) page of our website. You may suggest an alternative meeting place, but please be sure to determine the mileage from our office address before scheduling.

Choice 2

Over-the-phone Personalized Consultations are available both within San Diego and throughout the state and can be scheduled for a minimum of 1-hour.

After the first hour, you may purchase additional time at 1/2 hour increments at a cost of \$25 per. Phone consultations can be supplemented with email, fax, and/or regular mail, as agreed on. The fee from phone consultations is due at the beginning of the call.
