


### Regional Centers We Write Program Designs For

If your regional center is on our "No" list, that only applies to a Program Design. We can prepare license applications anywhere in the state. We can also consider any other regional center products or services we offer (e.g., consultations, Face Sheets, ISP's, etc).

Title 17, Section <u>56013</u>, *Program Design Requirements*, defines what information a Program Design shall include. All regional centers add additional requirements of their own.

Over the past 21 years, RA Mears Consulting has written some 1,500 regional center Program Designs. During that time, we have created a list of regional centers that we *will* and *will not* write Program Designs for.



 $\mathcal{I}$ f your regional center **does not** appear on the list, you can take these steps:

- Contact the person at your regional center that vendors new facilities.
- Request Program Design guidelines for the level facility your want to vendor.
- Email, fax, or mail those guidelines to RA Mears Consulting. We will review them and contact you to let you know if we can write the Program Design.

We <u>cannot</u> review any portion of a *Program Design* that you have prepared yourself. The document is too long and complex, usually taking regional center personnel weeks or months to review. It is more efficient for us to prepare a *Program Design* using our own templates.

The completed *Program Design* can be emailed or mailed, as agreed on. An emailed *Program Design* is sent in PDF format and *will not* be provided in a modifiable format (e.g., DOC, TXT). A mailed *Program Design* will require a \$25 processing fee.

Our *Program Design* is guaranteed. RA Mears Consulting will make any revisions to *our work* required by the regional center for *initial* vendorization without additional charge to you.
